Unlicensed providers who are not the Grandparent, Aunt, or Uncle to the child must be Trustline Registered with a Cleared Status before we can approve them as a provider and make a payment.

FAMILY FEE INFORMATION -

*Family Fees are based on the family's income and size. A Notice of Action will be mailed to you with your Full Time/Part Time family fee rate if it applies to your family.

FAMILY FEE RECEIPT MUST...

1. be an original copy
2. be pre-numbered
3. document the parent and provider's name, the date of payment, the period of service, the amount paid
4. have the signature of the person issuing the receipt (not a business stamp or the name of the facility)
5. be retained in the Child Care case file with the corresponding payment request.
6. *NEW* - document the rate of payment (FT & PT Family Fee rate must be indicated on the family fee receipt)*

QUESTIONS & ANSWERS

Q - Is Child Care eligibility based on low income only?

A - To qualify for CSA StanWORKS Child Care, the parent applying must have received CalWORKs cash aid within the last 24 months. They must also meet certain income limits and have an approvable need (Employment, WTW activities, school, etc.) CSA has a very small General Child Care program which we pull names off the Stanislaus Office of Education's Centralized Eligibility List (CEL) for families who have not received cash aid.

Q - Do children with a disability get a higher reimbursement rate?

A - Children with a verifiable special need (provides an IEP or IFSP completed from a school district or agency) may be reimbursed at a higher regional market rate if their licensed provider provides verification they have extra expenses because of the child's special need.

Q - Can anyone sign a child in or out on the yellow payment request form?

A - The actual person who is dropping the child off into child care must sign the child in. If the provider takes the child to school or picks the child up from school, they must initial the child in or out at that exact time. The actual person who picks the child up from child care must sign the child out. (Grandparent, relative, friends, etc...)

Q - If a provider's child care contract with the parent includes charges that the StanWORKS Child Care Program is unable to pay (late fees), how does the provider collect the money?

A - The parent is responsible for any balance or fee that our Child Care program can't pay. The provider needs to pursue the parent for payment.

Q - Can providers fill out the attendance part A of the request for reimbursement?

A - No, only the parent may complete this section. The parent must complete this daily as they leave or pick up their child from care. The only time the provider may write in this section is when they are dropping off or picking up the child from home or school.

• FRIENDLY REMINDERS •

* If you have an Address Change you must inform your CashAid worker & your Child Care worker immediately to prevent any interruption in services.

* Please review paper work for COMPLETENESS and ACCURACY each month BEFORE submitting payment request(s) to ensure timely payments.

* If a correction needs to be made on ANY of our forms: Cross out, then Initial & date. White out is not acceptable on any of our forms.

* Be sure attendance is completed daily on the payment request.
